Thank you for your freedom of information request via email received by the Ministry of Home Affairs on 20 March and forwarded onto us on 21 March 2014. The Ministry has informed us to respond to points e) – h) of your request. Therefore, where you have noted Cayman Islands Government we will interpret that to be just for the Office of the Auditor General. Your request is being dealt with under the terms of the Freedom of Information Law.

In the regards to the Office of the Auditor General the following information is provided in response to your requests:

- e. Number of persons in the Office of the Auditor General granted permission to engage in private employment.
  - > Three employees have been granted permission.
- f. Outside occupations of persons the Office of the Auditor General granted permission to engage in private employment.
  - ➢ Bookkeeper: 2-3 hours per week
  - Co-owner of fashion design/consulting business
  - > Consultant: one-off short-term consultancy to another Auditor General's Office in the Caribbean region
- g. Number of persons employed by the Office of the Auditor General or relatives supplying products or services to the Cayman Islands Government/Office of the Auditor General.
  - None
- h. Products or services supplied to the Cayman Islands Government by any employees of the Office of the Auditor General.
  - None

Under section 33 of the Freedom of Information Law, you may ask for an Internal Review of the response to your request where I have indicated we have do not hold any records. You have 30 days from the date of receipt of this Notice to request an Internal Review by writing to the Auditor General by e-mail at <a href="mailto:Alastair.swarbrick@oag.gov.ky">Alastair.swarbrick@oag.gov.ky</a> or by letter to the address above. When requesting for an internal review you should include:

- (a) your name, address and telephone number;
- (b) a copy of your Application and/or the Reference Number assigned to your Application;
- (c) a copy of this letter; and
- (d) if so inclined, the basis on which you are requesting a Review of the decision indicated.

If upon Internal Review, the decision is still not favourable to you, you have the right under section 42 of the FOI Law to appeal to the Information Commissioner within 30 days of:

- (a) the date of notification of the decision taken at Internal Review;
- (b) a decision taken by the Auditor General; or
- (c) the date on which you should have been notified of the decision referred to above but of which you received no notification.
