

### **Our Work**

The OAG reports on whether organisations that spend public money use it wisely and appropriately and that they are economical, efficient, and effective in their operations.

We do this by conducting performance and annual financial statement audits of public bodies.

We undertake 47 financial audits each year:



19 Ministries, portfolios, and offices



26 Statutory authorities and government companies (audit firms support the delivery of some of these audits)



Parliamen



The entire consolidated public sector account

OAG staff and audit firms appointed by us conduct the audits, checking whether the organisations manage their finances to the highest international standards and the law and achieve the best possible value for public money.

We also undertake special investigations and report on matters of public interest.

# How We Report On Our Work

The OAG reports its findings to Parliament and shortly thereafter our reports are made public.

### **Financial Statement Audits**

We provide an audit report on the accounts of each public sector entity we audit, indicating whether we consider the financial statements to be a fair reflection of their transactions and financial position. Each annual report includes our audit opinion and their annual financial statements. These reports must be tabled in Parliament and made public. We also provide the entities with recommendations for improving their financial management, governance and operations.

Annually, we prepare a general report for Parliament on the outcomes of all the financial statement audits undertaken and on any other matters we feel are necessary.

# Performance Audit and Public Interest Reports

We produce several performance audits and public interest reports every year. These focus on significant areas of government operations and issues of public interest, either in individual organisations or more broadly. We cannot comment on policy matters.

These reports are provided to Parliament and referred to the PAC, where they are considered in depth. Then witness sessions are usually scheduled so the PAC can probe further into the subject and make further recommendations for improving financial management and the delivery of government services.
